Abstract	This collection documents the art-collecting activities of Ira J. and Virginia H. Jackson. From 1996 to 2006, Dr. and Mrs. Jackson donated nearly 800 watercolors, prints, and drawings, including many by Pierre Bonnard, to the National Gallery of Art.

Biographical Note

Ira J. Jackson was born in Omaha, NE in 1920. He attended Duke University and graduated from New York University School of Medicine in 1943. Dr. Jackson then earned his Master of Science in Neurology from the Montreal Neurological Institute at McGill University in 1946. He practiced neurosurgery in Victoria, Texas before retiring in 1984. Virginia (née Hartle) was born in Owatonna, MN in 1919. She attended Carleton College and received her Bachelor of Arts from the University of Minnesota, and her B.S. in Library Science from The Pratt Institute in New York. She later earned a Master of Art History from the University of Kansas.

The Jacksons married in 1943 and began collecting art in the 1960s, concentrating on works by The Nabis, a group of young French artists active in Paris from 1888 until 1900, and particularly those by Pierre Bonnard. From 1996 to 2006, the Jacksons donated nearly 800 watercolors, prints and drawings to the National Gallery. An exhibition of the Jackson collection, *Prints Abound: Paris in the 1890s: From the Collections of Virginia and Ira Jackson and the National Gallery of Art,* was held from October 22, 2000 to February 25, 2001.

Scope and Content

This collection documents the art-collecting activities of Ira J. and Virginia H. Jackson. It includes correspondence with dealers relating to the acquisition and purchase of works of art. Other materials consist of appraisals, inventories, travel itineraries, research notes, invoices, shipping records, and collection information cards. Of note are materials relating to the Jacksons particular interest in Pierre Bonnard.

Series Descriptions

Series 1 General Correspondence, 1970–2002 [boxes 1-2]

This series consists of correspondence relating to the Jacksons' general art-related interests and activities, such as exhibitions, visits to print rooms and galleries, art auctions, and gifts or loans. Also included are photographs of works of art, receipts, holiday greeting cards, and social exchanges.

Series 2 Dealer Correspondence, 1973–2001 [boxes 3-5]

This series consists of correspondence with art dealers, relating to works of art for sale, purchase and shipping, and auctions and print fairs. The files also contain clippings and research notes on specific works for purchase consideration.

Series 3 Subject Files, 1978-2007 [boxes 5-8]

This series includes general art-related subject files and consists of appraisals, inventory lists, travel details and itineraries, photographs, research notes, auction catalogs, and art handling, conservation and preservation notes.

Series 4 Invoices, 1971-2002 [boxes 8-10]

This series consists of invoices, letters of proof of purchase, and cancelled checks documenting the Jacksons' purchases of works of art, art books, and art catalog subscriptions.

Series 5 Bonnard Research and Acquisition Files, 1975–1998 [boxes 10-11]

This series consists of files pertaining to the Jacksons' specific collecting interest in Pierre Bonnard and the Nabis. Files include information on exhibitions, loans, photographs, and specific works of art in their collection.

Series 6 Card Files [box 12]

This series consists of card files detailing works of art in the Jacksons' collection. The cards include title, acquisition, valuation, insurance, and descriptive information. The cards also provide details related to the Jacksons' editions of *L'Epreuve*, a print album published between December 1894 and December 1895 by Maurice Dumont.
